Just as 911 serves as the nationwide emergency call number for medical, fire, or other emergencies, 988 will serve as a nationwide mental health crisis line that will connect callers to crisis resources, regardless of location. 988 will be rolling out nationwide on July 16, 2022, and stakeholders across the state have been hard at work to ensure a successful launch of the program. This presentation will update the Rural Regional Behavioral Health Policy Board and meeting attendees regarding how 988 will work, how callers will be connected to local services, and how local first



responders will be affected.
