- 3.) **Informational: Brief Review and Statement of Meeting Goals**

The goals of this meeting of the Rural Regional Behavioral Health Policy Board (Rural RBHPB) Subcommittee for Bill Draft Request (BDR) Development will include: to hone the concepts prioritized by the participating Board Members during the meeting held on July 22, 2022, and flush out further concepts as necessary. What resources would be needed to bring existing resources together and to add additional programs and services identified above?

Where would the pipeline center be housed?

How many staff would be necessary to build the pipeline program?

What funding sources might be available to launch the pipeline program?

What parts of the pipeline program concepts require legislative fixes, and what parts do not?
