Assembly Bill 274

During the 2021 Nevada Legislative Session, Nevada Fertility Advocates supported Assembly Bill 274 (D-Gorelow). Existing law requires public and private policies of insurance regulated under Nevada law to include certain coverage. Existing law also requires employers to provide certain benefits to employees, including the coverage required for health insurers, if the employer provides health benefits for its employees. This bill aimed to require that certain public and private health plans provide coverage for standard services for fertility preservation because a covered person: (1) has a medical or genetic condition that may directly or indirectly cause infertility; or (2) is expected to receive medical treatment that may directly or indirectly cause infertility.

Although AB274 did not pass during the session, NFA remains committed to advocating for fertility preservation (and beyond) legislation in the future.



Advocacy Day

Advocacy Day is an event where the infertility community comes together to talk to members of Congress about important issues, like increased access to family building options and financial relief. Each year we partner with RESOLVE: The National Infertility Association and the American Society for Reproductive Medicine (ASRM).

Together we spend our day with others who support the pro-family movement our organization cares deeply about. Many of the advocates have experienced infertility or are still on their journey to parenthood. It is an opportunity for all to share their impactful experiences with Representatives from Nevada with the hope of advancing legislation that will provide additional familybuilding resources to our citizens. Cost is the number one barrier to medical treatment, as 46% of people do not have insurance coverage for infertility, according to a 2012 RESOLVE survey. To improve access to care, we must remove financial obstacles to care. Nevada Fertility Advocates is committed to increasing the number of people with access to health insurance that covers infertility medical treatment.

We are committed to increasing the number of people with access to family building benefits through their employer. That is why we work with local employers to help empower employees and employers to make decisions that lead to better employer-provided family-building benefits for all.


