4. Update on the Children's Behavioral Health Transformation Public Workshop-Informational Only

This presentation highlighted Medicaid's vision, new Medicaid Home and Community Services, how they are strengthening the quality in residential settings, other Medicaid investments and changes, the financing mechanisms, the state of mobile crisis response, and their planned next steps.

Chair Faison asked if they are looking to increase the provider base that is qualified to perform services, stating there's a lack in areas that are going to be required to make all this work. Dr. Major asked about families that need assistance but are far away from treatment and how treatment can be provided. Ms. Dearborn stated they are looking to revise their policies for those types of providers.
