Adult Jail Diversion and Reentry

Northern Nevada Hopes

Purpose of Award: Northern Nevada HOPES will develop and implement two (2) adult Criminal Justice Diversion Programs – Reentry and Diversion.

NAMI Nevada

Purpose of Award: NAMI Nevada in partnership with its Affiliates, NAMI Western, NAMI Southern and NAMI Northern, will provide the Community and Criminal Justice Program to support maintaining and/or achieving recovery for those living with a Serious Mental Illness; reducing the human and fiscal cost and consequences of repeated arrests and incarceration for people with mental health issues.



Assertive Community Treatment

Carson Tahoe Health

Purpose of Award: To provide comprehensive and coordinated specialty care for individuals who are suffering from severe mental illness.





Community Based Treatment

Crisis Support Services of Nevada

Purpose of Award: Builds infrastructure for receiving calls from people who are Seriously Mentally Ill (SMI) or Seriously Emotionally Disturbed (SED) based on a formula approved by SAMHSA. Continuing to expand and maintain infrastructure for SED/SMI individuals to call into the national suicide prevention lifeline.

NAMI Western Nevada

Purpose of Award: NAMI WNV will continue to operate the Warmline in both English and Spanish to provide support at an appropriate lower level of care for Nevadans experiencing mental illness and/or mental health crisis, who are at risk for hospitalization, law enforcement contact or use of other crisis services.



Youth Jail Diversion

Northern Nevada Hopes

Purpose of Award: Northern Nevada HOPES will develop and implement a juvenile justice diversion program for adolescents with a Serious Emotional Disturbance (SED) determination who have had initial contact with the Juvenile Justice System or those with behaviors indicative of risk of future contact.

Purpose of Award: Provide outpatient therapeutic and counseling services to children and youth up to age 18 with Serious Emotional Disturbance (SED) determination

Division of Child and Family Services

- **Purpose of Award:** Adolescents with Severe Emotional Disturbances/Serious Mental Illness in Washoe County will have increased access to rapid mobile crisis response and stabilization, mental health assessment and timely access to wrap around tiered care coordination response through the Mobile Crisis Response Team-Engagement Team (MCRT-ET).
- **Purpose of Award:** Adolescents with Severe Emotional Disturbances/Serious Mental Illness in Clark County will have increased access to rapid mobile crisis response and stabilization, mental health assessment and timely access to wrap around tiered care coordination response through the Mobile Crisis Response Team-Engagement Team (MCRT-ET).
- **Purpose of Award:** The Planning and Evaluation Unit (PEU) will support the implementation of the newly developed programs of the Southern Nevada Child and Adolescent Services and the Northern Nevada Child and Adolescent Services by providing a complete package of evaluation activities directed at providing the programs with timely and meaningful data to help drive their development.



Youth/Adolescent Services

United Citizens Foundation

Purpose of Award: To provide assessments and services including but not limited to referrals to mental health treatment, treatment for SED for school-aged children and their families throughout the Clark County area.



Youth/Adolescent Services

Chicanos Por La Causa

Purpose of Award: Provide a pediatric psychiatry access line (PAL) for consultations to improve access, diagnostic accuracy, and treatment plans for youth with Serious Emotional Disturbance (SED) determination.



Technical Assistance

CASAT

Purpose of Award: Provide training and support for certifications, data gathering, usage, and reporting; conduct site visits and technical assistance to the CCBHC's and 1 independent ACT team in the State of Nevada; and assist in the development of provider qualification and certification criteria in the 1915(i) program.

Regional Behavioral Health Coordinators

5 Regional Behavioral Health Coordinator Positions

Purpose: Provide funding for the Regional Behavioral Health Coordinator (RBHC) to help build community capacity through board activities to improve access to treatment, education, and related behavioral health services to persons with Serious Mental Illness (SMI) as well as those who may have co-occurring or separate substance use disorders, including opiate and stimulant dependence/use.
