1. Welcome and Introductions

Mr. Quint opened the meeting by welcoming attendees and providing a brief overview of the Bureau of Behavioral Health Wellness and Prevention (BHWP). He Explained the integration of services that had been combined into one agency. Those programs include HIV/Ryan White, Behavioral Health Services Planning, and the Substance Abuse Prevention and Treatment Agency.

Mr. Quint said funds from the Mental Health Block Grant will be included for the first time as a competitive grant, to be used as payment of last resort for targeted case management, recovery support, inpatient programs, and for creating a system of care. Additionally, there will be funds available for youth in the first breakdown or episode.

Criminal Justice will be providing funds for youth and adults in or emerging from the criminal justice system.

Women's services are special funds for pregnant women with addiction, women's services, and women with dependent children.

Mr. Lovgren read from a prepared statement:

The RFA called for programs to comply with federal Block Grant regulations, but that the Block Grant regulations imposed few requirements upon the programs. Instead, they more commonly make the State responsible for imposing a requirement upon programs funded with Block Grant funds. For example, the Block Grant regulations don't require treatment programs serving injection drug users to conduct outreach to that population. Instead they impose upon the State responsibility for requiring this. The question, then, is, how will Nevada impose upon funded programs the requirements that the State's required to impose?
