3.) Review and possible approval of meeting minutes from June 16, 2023 - Action Item

4.) Update of Oral Health Program. Informational – Jannette Gomez, Nevada Public Health Dental Hygienist, Division of Public and Behavioral Health

The Nevada Oral Health Program has completed the Evaluation Plan and Implementation plan for the Nevada Oral Health State Plan 2022-2032. These will be shared at each AC4OH quarterly meeting. The Implementation Plan will be updated each year and shared with the AC4OH for input on activities and timelines. The implementation plan will be addressed at the beginning of each fiscal year for the following year's activities. The plan will be evaluated at the end of the fiscal year and shared with the AC4OH committee. The 3<sup>rd</sup> grade Basic Screening Survey will be complete by the end of the year with UNLV partnership.

**5.**) Nevada Medicaid Dental Benefits and American Rescue Plan Act (ARPA funding). **Informational – Dr. Benson** 

Services for ID/DD Medicaid dental benefits, funded by ARPA will continue. 1115 Waiver, still awaiting CMS approval, hoping for early fall. Tribal Health Clinics have been added to Waiver. There will be a final list of Tribal Health Clinics that will want to participate. Medicaid rate increase for PT 22 and PT 20 providers, 5% increase, will be implemented January 1, 2024. Legislation SB 44- passed, puts State Public Health Dental hygienist and the Dental Director under the director's office, change in licensure and ability to work outside of positions. AB 147-Bill authorizes teledentistry and vaccination by dentists and dental hygienists, will be implemented January 1 after getting regulations from state dental board. SB 385- includes addition of fillings and crowns for adult dental benefits, left our preventative and periodontal piece which will pose challenges for providers, bill is in progress. SB 310 expands functions of dental assistant and dental hygienist, January 1, 20024 for implementation with regulations needing to be developed by Nevada State Dental Board of Examiners.

6.) Update on American Rescue Plan Act (ARPA) funding for school based oral health programs. Informational- Ms. Lynn Short

Applications were due June 30<sup>th</sup>. Working with 8 entities for subrecipient agreements. Applications are currently in review process. Start date projected for September 1, current grant period through June 30, 2024. Another RFA will be released in September for additional funding.

NDHA will have a lot of work in front of them on the implementation of these bills that passed this year. Our main concerns moving forward should include submitting a request to the dental board for a workshop regarding the newly passed dental bills so they will not delay implementation, and schedule a meeting to work on licensure compact language for 2025 and having NDHA as a primary driver, not a sideline member of discussions.

- 9.) Improving the delivery of preventative services for children aged 2-20 and coordination of transportation services for eligible Nevada Medicaid program enrollees. Informational Dr. Arian

Delivery of preventive services for children. Community events to outreach parents and guardians to educate them or oral hygiene instructions and scheduling appointments. School based programs relationship. The goal is to identify the highest volume of non-utilizers. Propriety value-based program BRUSH. This program encourages providers to increase utilization, providers are incentivized and rewarded when improvement is seen.

10.) Presentation of general anesthesia cases in Las Vegas, experiences, and challenges.

#### Informational- Sun Valley Surgery Center

Business director at Sun Valley- Gina Hernandez. Serve kids and special needs patients. Facing a lot of challenges. State cut funds by 50%, no longer lucrative to see children. We ended up seeing all the kids waiting for surgery. We would rather go bankrupt, than not see these kids. Demand was huge. We work 12-14 hours a day, even Saturdays. The fixed rate at \$965 is barely cutting it with all expenses. We are facing a new issue, anesthesia shortage. Anesthesia is not reimbursing appropriate amounts. All supply costs have gone up 20-30%, and labor has gone up after COVID. We were the only surgery center open during COVID. We would like to know, who can we advocate with? Who can we contact to raise rates? There is also a critical anesthesia shortage in Nevada. Sun Valley used to supplement and pay stipend, since rates have been cut, they can no longer do that. There has to be something we can do with DHCFP. Utah and Minnesota have increased rates. Other states are doing it. Dr. Weichers states the rate that is acceptable is what Medicare says is acceptable. Medicare has raised rates, but Medicaid is not ready to raise rates. Dr. Putnam suggested that the AC4OH submit a letter of support and Terri Chandler suggested that this subject continue to be a line item on the AC4OH agenda.
