Facility Type	Facility Description
Food Establishment (Restaurant)	Restaurant means any area, including outdoor seating areas, or portion thereof in which the business is the sale of food for on-premises consumption which stores, prepares, packages, serves, vends food directly to the consumer; provides food directly to a consumer institution; or food bank; and may provide take out or delivery. This category includeds convention and community centers.
Food Establishment (Bar/Service Bar)	Bar means any area, including outdoor seating areas, devoted to the sale and service of alcoholic beverages for on-premises consumption and where the service of food is only incidental to the consumption of such beverages. "Service Bar" means any area devoted to the sale and service of alcoholic beverages that is used by the facility to make and distribute beverages to servers for public distirubtion. This category includes convention and conference center bars.
Food Establishment (Snack Bar)	Snack Bar means a food operation that operates on a full time basis. Includes any area where packaged food, snacks, beverages are provided that has limited PHF/TCS items. Examples may be hot dogs served inside a market which otherwise only offers prepackaged food items and soda with ice. Follow the guidance document "Licensure of Snack Bars in Convenience Stores or Markets"
Food Establishment (Concession)	Concession means a food operation that operates at a part time basis such as those which operate at a sports facility or a municipal football, baseball or soccer field. Concession operations serve low risk prepackaged food items, pretzels, hot dogs, and other limited, approved, PHF/TCS items. Not included in this definition are facilities located on a Public Private or Charter School.
Food Establishment (School Concession)	Concession means a food operation that operates at a part time basis such as those at a Public Private or Charter School which operate one or multiple sports facility football, baseball or soccer fields. Concession operations serve low risk prepackaged food items, pretzels, hot dogs, and other limited, approved, PHF/TCS items. This fee may include more than one facility located on school grounds.

Food Establishment (Portable Food Unit)	Portable Food Unit means a piece of equipment operated within a building and pursuant to a contract with a food establishment or an approved servicing depot for the preparation and service of a limited menu that has been approved by the health authority. Examples include coffee carts and hot dogs carts. These units may have a service depot where food is stored, untensils are washed and water is obtained and discarded.
Food Establishment (Bed & Breakfast)	Bed and Breakfast means a commercial home offering bed and breakfast accommodations to one or more persons per night for a period of less than 1 week. [Reference: NAC 446.845 to 446.860]
Food Establishment (Correctional Facility Kitchen)	Correctional Facility means a food establishment within a correction facility that prepares foods for the inmates or staff.
Food Establishment (School Kitchen)	School Kitchen means a facility inside a public insititution that serves food to students or staff.
Food Establishment (Catering)	"Caterer" means an approved food establishment that is capable of serving or preparing food at a location other than its primary location.
Food Establishment (Exempted-NRS 446.870)	See: NRS 446.870
Food Establishment (Mobile Units)	"Mobile unit" means any vehicle operating from an approved service depot or servicing area, in which food, beverages, frozen desserts or dairy products and mixes are prepared, processed or converted for human consumption and which is used to sell and dispense food and beverages to customers. The term does not include a push cart or any similar operation.
Food Establishment (Service Depot/Area)	Service Depot or Servicing Area means an operating base location to which a mobile food establishment or transportation vehicle returns regularly for such things as vehicle and equipment cleaning, discharging liquid or solid wastes, refilling water tanks and ice bins, and boarding food. This fee is not optional. All mobile food vehicles require a service depot or servicing area.
Food Establishment Support Facility (Support Kitchen)	Support Kitchen means a kitchen facility that is devoted to processes and operations in support of kitchen and food preparation spaces, that may not be used on a regular basis.
Food Establishment Support Facility (Portable Bar Unit)	Portable Bar Unit means a portable unit which serves mixed drinks, beer or other beverages. They are stocked for service and are not operated continuously.

Food Establishment Support Facility (Barbeque)	"Barbecue" means an area or facility at a food
	establishment, other than the main area for preparing food, that has equipment for cooking food. [Reference
	NAC 446.011]
Food Establishment (Retail Warehouse)	Retail Warehouse means a storage area for food products which may include shelf-stable products, coolers and dry storage. Examples include school warehouses and storage areas inside a large multi-food establishment facility whch serve meals directly to the public (i.e.,casino).
Food Market (Bakery)	Bakery means packaged bakery for retail distribution, directly to consumer which is processed inside a retail food establishment.
Food Market (Deli)	Deli means food typically sold at a delicatessen such as cold cuts, sliced cheeses, salads, that are generally received prepared or in a ready-to-eat form.
Food Market (Meat)	Meat means packaged meat for retail distribution, directly to a consumer which is processed inside a retail food establishment. (i.e., Butcher). Poultry is included for this description.
Food Market (Packaged Foods)	Packaged" means contained in a bottle, can or carton or securely held in a bag or a wrap. These foods are mostly shelf stable products. ₹1000 sq. ft. = \$166
Food Market (Seafood)	Seafood means packaged seafood for retail distribution, directly to a consumer which is processed inside a retail food establishment.
Manufactured Food (GMP)	GMP means wholesale food processing for wholesale which require only good manufacturing practices to maintain food safety, and without a special process included.
Manufactured Food (Acidified)	Acidified means wholesale food processing that are low-acid foods to which acid(s) or acid food(s) are added; they have a water activity greater than 0.85 and have a finished equilibrium pH of 4.6 or below (21 CFR 114.3(b)). The definition of acidified foods provides that carbonated beverages and foods that are stored, distributed, and retailed under refrigeration are excluded from the coverage of 21 CFR part 114 (21 CFR 114.3(b)).
Manufactured Food (Aseptic)	Aseptic means wholesale food processing that undergoes thermal processing of a low-acid food packaged in hermetically sealed containers.

Manufactured Food (Low Acid Canned)	Canned means packaged canned for retail distribution, directly to consumer which is processed inside a retail manufactured establishment.
Manufactured Food (Meat/Poultry)	Packaged meat for wholesale distribution to a retail outlet.
Manufactured Food (Juice)	Juice means wholsale juice and juice products means the aqueous liquid expressed or extracted from one or more fruits or vegetables, purees of the edible portions of one or more fruits or vegetables, or any concentractes of such liquid or pure as defined in 21 CFR 120.1(a). Juice producted by a person who operates a retail food establishment is not covered by this description.
Manufactured Food (Seafood)	Seafood means wholesale seafood fish or fishery products as defined: (a) Fish means fresh or saltwater finfish, crustaceans, other forms of aquatic animal life (including, but not limited to, alligator, frog, aquatic turtle, jellyfish, sea cucumber, and sea urchin and the roe of such animals) other than birds or mammals, and all mollusks, where such animal life is intended for human consumption. (b) Fishery product means any human food product in which fish is a characterizing ingredient. This description does not include those products regulated under the "Shellfish Distribution Program" (Code: 32)
Manufactured Food (Supplements)	Supplements means a dietary supplement product intended for human consumption or ingestion that contains a "dietary ingredient intended to add further nutritional value to the diet. The "dietary ingredient" may be one or any combination, of the following substances such as a vitamin, a mineral, an herb or other botanical.

Manufactured Food (Warehouse)	Warehouse means a storage area for food products which are directly shipped from a manufacturing food facility or food processor. The purpose of these facilities is to distibute to local retail facilities or retail warehouses. Examples of these facility types: dietary supplements and dietary ingredients, infant formula, beverages (Including alcoholic beverages and bottled water), fruits and vegetables, fish and seafood, dairy products and shell eggs, raw agricultural commodities for use as food or components of food (which do not include: FSMA exemption for "Storage facilities only raw agricultural commodities (low risk items such as grains.") Canned or frozen foods, bakery, goods, snack food, candy, chips, gum, live food animals, animals food and pet food.
Manufactured Food (Bottled Water)(In-State)	In-State means bottled water products as described in NAC 445A which are bottled inside of the State of Nevada.
Manufactured Food (Bottled Water) (Out-of-State)	Out-of-State means bottled water products as described in NaC 445A that are sourced and bottled outside of the State of Nevada.
Shellfish Distribution Program	Shellfish means all species of oysters, clams, mussels (shucked or in the shell; raw including post harvest processed; frozen or unfrozen, whole or in part) and scallops in any form for wholesale buying, repacking or for sale.
Certificates of Free Sale	Certificate of Free Sale is defined as a certificate completed and issued by the Division of Public and Behavioral Services attesting that a specific food, drug, cosmetic product regulated by the State of Nevada Administrative Code or Nevada Revised Statute is manufactured, distributed and offered for sale in this State is labeled in conformance with the applicable food, drug, or cosmetic laws.

Farm to Fork Registration	Farm to Fork see NRS 446.868.
Label Review (ALL)	Label reviews may be performed for these facility types: Bottled Water Distributor, Food Retail/Processing Establishment, Dietary Supplements, Certificate of Free Sale, Cosmetic Manufacturer, Drug Manufacturer.
