New CLiCs Update!

Individuals who lock themselves out of CLICS now have a way to unlock their account themselves without calling the office. If you were to lock yourself out of your account, the system will redirect you to the "forgot password" page. You will then be prompted to enter required information for the system to send a notice and link to the email on file to reset your password. Please know, the system only gives you 30 minutes to submit the reset request and create a new password. If you do not reset the password within 30 minutes you will need to call your surveyor. If you have any questions about the password reset process please call your surveyor.

CPR/1st Aid Training Reminders:

Did you know that CPR and First Aid trainings can be taken from ANY certified CPR instructor, regardless of whether they are listed in the <u>CPR instructor listing</u> on Nevada Registry's website, as long as an official certification card from one of the five approved agencies will be issued. The 5 automatically approved agencies can be found listed in <u>NAC 432A.322.4</u>

<u>What does this mean?</u> You will no longer receive a Certificate of Completion with a Registry approval code, nor will an approval code be listed on your certification card for CPR/First Aid training.

Contact the instructor to confirm which card will be issued BEFORE registering for the class. If they cannot guarantee that an official card will be issued, DO NOT TAKE THE TRAINING.

*Please keep in mind that it may take time to receive your CPR/First Aid card. Be proactive and have yourself & staff take the training early in order to ensure cards will be on hand in time for the staff file review portion of your inspection! *

The Pacific Institute recently released <u>Drinking Fountains and Public Health: Improving National Water Infrastructure to Rebuild Trust and Ensure Access</u>, which finds limited evidence between illness and the use of drinking fountains. The authors note that the risk of fountain water contamination can be reduced or eliminated altogether through improved maintenance and cleaning or updating and replacing old water infrastructure.

While State of Nevada Child Care Licensing does not require facilities to have a drinking fountain on site, if your facility has a drinking fountain on site we strongly encourage you to read the report by clicking the blue link above and viewing the attached Media Release.

Summertime Sun Safety:

Summer is here in full force along with triple digit temperatures! Child Care Licensing would like to offer some sun safety reminders for the upcoming months.

-Children should be drinking five ounces every 20 minutes during outdoor activities to prevent dehydration. Tip: A child's "gulp" equals half an ounce so children should drink 10 "gulps" for every 20 minutes of play.

-Remember, children must be offered drinking water throughout the day, not just at meals. NAC432A.385.1(e)



-For children 6 months and older: Apply sunscreen early; Children's sunscreen should be applied 15-30 minutes prior to outdoor activity in order for the sunscreen to absorb into the skin. Remember, sunscreen should only be applied to children under 6 months if specific to their age.

-Limit outdoor activity to early morning and late evening, avoid peak sun hours between 10a.m. and 2 p.m. as much as possible.



-A shade area must be "at least equal in size to the sum of 5 square feet multiplied by the total number of children in the play area." through the months of April- September.



-Check for hot surfaces on playground equipment before allowing children to play on it. Surfaces can become extremely hot and can cause burns on the skin.



-Encourage parents to bring in hats, sunglasses, and light weight clothing to offer protection from the sun during outdoor play.



-If children are unable to stay outside for the duration of their scheduled outdoor time, ensure gross motor activities and time to get their energy out is offered indoors.



-Keep in mind that infants and toddlers are unable to tell an adult when they are too hot and most young children need to be reminded to stop playing to cool down. Remind staff to be diligently watching for signs that a child may be overheating.



Southern Nevada Health District: Updated Bleach Recipe

For our child care providers in Las Vegas; bleach concentrations have been updated! All recipes used in Southern Nevada Health District regulations and guidelines were based on a bleach solution that is no longer being manufactured. In order to make the appropriate strength solution, the Southern Nevada Health District states it is ESSENTIAL that you:

1. Follow the manufacturer's label instructions for dilution and verify

the strength using chlorine test strips.

- 2. Comply with the label instructions for the required contact time for either sanitizing or disinfecting purposes.
- 3. Provide potable water rinse if required by the manufacturer.



All other licensed child care facilities should be following the bleach solution recipe that is listed in NAC 432A.414.

-> The Consent and Release form for employee background fingerprinting has recently been revised. Information for "friends, family, and neighbors" providers to fill in has been included in the form.

Another revision included also states that new employees who have not resided in the State of Nevada for the past 5 years will be required to produce a cleared background(s) of criminal and child abuse from each previous residential State within 90 days of hire.

All facilities are to use the updated consent and release form and fill it out <u>completely</u> or it will be rejected. The new form can be found on the <u>Forms-Background</u> section of the Child Care Licensing website.

August arrives each year along with a new school year. Friends for Sight wants to make sure that children include an eye exam as part of their back to school check list. The inability to see clearly affects not only academic performance but also athletics and self-esteem.

Common signs of vision troubles in children include: Frequently rubbing eyes, squinting, tilting or turning head to look at objects, wandering eyes, or squeezing eyes. If children in your care display any of these symptoms, parents should be informed so they can schedule an appointment for their child to get their eyes checked.

Eye safety is just as important as eye health. By taking proper precautions (such as providing age-appropriate toys), you can help protect children from injury. If a child should experience an eye injury, don't allow the child to rub or touch the eye, don't' apply medication, and don't attempt to remove any debris from the eye.



September is Baby Safety Month!

Drinking Fountains and Public Health: Improving National Water Infrastructure to Rebuild Trust and Ensure Access

February 27, Oakland, Calif. – Today the Pacific Institute released <u>Drinking Fountains and Public Health:</u>
Improving National Water Infrastructure to Rebuild Trust and Ensure Access, which finds limited causal evidence between illness and the use of drinking fountains. The authors note that the risk of fountain water contamination can be reduced or eliminated altogether through improved maintenance and cleaning or updating and replacing old water infrastructure.

Concerns over drinking water quality and possible disease transmission as well as widely-publicized water contamination incidents have contributed to a decline in the number of publicly available water fountains. Yet many people – including children, commuters, joggers, tourists, and the homeless – rely on drinking fountains for cheap, accessible, and safe municipal water.

To ensure the safety and continuance of this valuable public resource, the report authors recommend:

- Establishing comprehensive monitoring and testing of all drinking fountains;
- Developing and implementing standard protocols for water fountain maintenance, repair, and replacement;
- Creating broad nationwide efforts to replace old water infrastructure, especially distribution and plumbing systems, with modern piping to eliminate sources of lead, copper, and microbial contamination;
- Upgrading the type and function of older drinking fountains, for example, by installing filters;
- Greatly increasing the number of fountains to improve access to municipal water in public places;
- Engaging municipalities, schools, park districts, and others responsible for drinking fountains in communications efforts to help rebuild public confidence in fountains;
- Using new tools to compile and distribute information on where to find drinking fountains and to assess and report on their condition.

These actions would help ensure that drinking fountains remain clean, safe, and accessible to the public.

IMPORTANT INFORMATION ABOUT NEW BLEACH CONCENTRATIONS

For those of you who use a diluted bleach solution for sanitizing and disinfecting your child care facility, manufacturers of household bleach have changed the concentration of bleach sold by retail stores and chemical suppliers. The new bleach solutions vary between 6.0 % to 8.25 % sodium hypochlorite solution. These concentrations are higher than the formerly available bleach solution of 5.25 % that is no longer being manufactured. All recipes used in SNHD regulations and guidelines were based on a 5.25 % solution of sodium hypochlorite and should no longer be used.

Because of the differing concentrations, the recommendations for diluting a bleach solution for sanitizing or disinfecting depend upon the specific bleach. It is no longer possible to provide a generic bleach recipe for sanitizing and disinfecting.

In order to make the appropriate strength solution, it is ESSENTIAL that you:

- Follow the manufacturer's label instructions for dilution and verify the strength of the solution using chlorine test strips.
- Comply with the label instructions for the required contact time (keeping the surface wet with the bleach solution) for either sanitizing or disinfecting purposes.
- 3. Provide a potable water rinse if required by the manufacturer.

A SANITIZING SOLUTION needs to be used for food contact surfaces such as: dishes, utensils, tables and high chair trays, or toys that a child may place in the mouth.

A DISINFECTING SOLUTION needs to be used for: diapering areas, bathrooms, general purpose on floors, walls, high touch areas, and toys that are not placed in the mouth.

- USE ONLY EPA registered products for sanitizing and disinfecting
- . ALWAYS follow the manufacturer's instructions that are listed on the label
- CLEAN FIRST prior to ANY sanitizing or disinfecting, scrub with soap and water, followed by a water rinse to remove soap and other residue
- . DO NOT mix bleach solutions with other household chemicals
- · PREPARE working containers of sanitizing and disinfecting solutions daily
- DO NOT use scented, splashless or color-safe bleach
- OBTAIN and USE chlorine test strips to verify proper dilution as specified by the manufacturer
- . ASSURE proper contact time prior to returning item or surface to use
- CLEARLY LABEL all working containers, and keep out of reach of children
- FOLLOW manufacturer's label instructions for possible required water rinse following the appropriate contact time
- . WHEN YOU USE a new bottle of bleach, remember to check the manufacturer's label instructions
