Handtevy

The Nevada EMS-C Committee is very excited to announce that we have grant funding to supply Handtevy mobile for all of our EMS providers in the State of Nevada. This system is designed to guide EMS providers in both pediatric weight estimation and accurate pediatric medication dosing and SO much more. It has been shown to decrease medication errors and improve outcomes and safety for our children. We are developing contracts with our EMS provider groups, and we will start training in the next 2 months. Mountain View Paramedic Institute will be in charge of training, and we have many trainers ready to go who have taken the instructor course. Nevada ED Pediatric Readiness Recognition Program

The Nevada EMS-C Committee is very excited to announce that we have developed a Pediatric Emergency Department (ED) Readiness Recognition Program for the State of Nevada. Research has shown that high pediatric readiness in EDs results in a 76% lower mortality rate in ill children, a 60% lower mortality rate in injured children, and at least 1400 children's lives saved across the US every year. We have developed 4 levels of recognition based on the EDs available resources:

Peds Ready

Peds Ready +

Peds Ready Advanced

Peds Ready Advanced +Trauma

A document explaining the four levels and the categories that are included in the designations can be found on our Nevada EMS-C website or contact Michael Bologlu at: mbologlu@health.nv.gov. Each ED will choose the level of designation they wish to achieve and complete an application. The applications will be reviewed and we will help EDs to accomplish the requirements if they would like. Once the requirements are met the EDs will receive a certificate, recognition by the state of Nevada, and the names of the EDs that receive a designation will be published and disseminated on social media.
