(LCB File No. R105-22)

The changes to NAC 450B in LCB File No. R105-22 are to clarify the effect of criminal convictions on background checks and fingerprinting submissions.

- Specific criminal convictions defined that make an applicant ineligible for certification
- Required frequency of fingerprint submission to be in alignment with NRS 450B.800
