There was discussion among the members of additional links that could be added.

Veneta Lepera suggested that on the provider portion of the web site, they include a link that gives guidelines for a provider, director, etc.

Nathan Orme said if the goal is to bring more attention to the Resource for Families document, a paragraph explaining why may be helpful, which would include a link on the web page.

The Chair said she would like to the see videos uploaded to Facebook, Twitter, Instagram so that they know the Palliative Care Page is there. She added whatever is going on each month





could be highlighted. She added that a rotating roster could be distributed that highlighted each member.

Kim Anderson suggested a post for National Healthcare Day would give the page more attention.

Nathan Orme suggested that current happenings should be kept to social media.

Stephanie Schneider suggested including an email where the public could send their general questions and receive an email with FAQ about Palliative Care. Regarding the FAQ, what questions should a person ask, would be most useful to the user if it was located somewhere that was easily accessed.

Mary Ann Brown said she serves on the Child Care Services Board which allows providers to do their own updates on the web page. This might make it easier for the individual programs to keep their information up to date.

Nathan Orme commented that state web sites said that they do not allow external people access to change the web sites.

Mary Ann Brown commented the web site is a state web site and she would send him more information on it.

Veneta Lepera said it is so important that everyone give their input for the web page.

Veneta Lepera commented that she and Kim will send a statement to post on the web page once a month. She emphasized the importance to be on social media so that they know the palliative care page is there.

Veneta Lepera said that they could highlight a Palliative Care Council member monthly.

Nathan Orme said if everyone provides content, he said to think of communication as a pyramid. He said have a topic, now where are we going to disseminate this information. The goal is driving people back to the web page. Facebook, Twitter and Instagram are the social media that is available. He suggested using social media for events.

7. Open discussion about open seat on the council and possible action to recommend to the Department of Health and Human Services Director the appointment of members. One opening for a board-certified hospice and palliative care physician or nurse. Action Item – Veneta Lepera

Veneta Lepera commented there is one open seat on the council. She encouraged everyone to spread the word and maybe by the next meeting there would be some candidates. If anyone is interested in an exofficio position we are not limited to the number of members. If a person is passionate and has expertise with palliative care that is important regardless of where they work.

There was a discussion regarding how to recruit new members to replace the open slot on the Palliative Care and Quality of Life Advisory Council. Nathan Orme shared the By-Laws which said that new members can be nominated by the council but the final decision is made by the Director's office.

8. Discussion and possible approval of *partially completed* letters of support to Medical Schools and Nursing Schools outlining the value of implementing enhanced training on Palliative Care and quality of life. **Action Item - Patti Pollina/Kelly Conright** 

Chair Lepera asked everyone to review the letters and suggest some additional language. The letter is on the TEAMS web site. She can send the letter to all the council members again and see if there was something you want to add. This letter would be sent out to nursing schools, medical schools, encouraging them palliative care in their curriculum.

Mary Ann Brown suggested starting the letter with a story.

Melissa St. Jean commented that if they do a story, pick a patient that would use the services for 18 months instead of someone that would just use it for six weeks. She said she tries to educate the providers on this.

Stephanie Schneider said that this reminds me of opportunities to make presentations at schools and in person.

Veneta Lepera said she was asked by the School of Medicine at UNLV to speak to the geriatric physicians. She said she was honored and excited to talk to these new physicians.

Nathan Orme said when you sign up for the engagements or events, ask if they are recording video or audio and get a copy to post on the web page. He added when you were talking about highlighting each council member, we could use little sound bites or videos on social media.
